## 2022 SNAP HIP CSA Membership Agreement

Community Supported Agriculture (CSA) programs provide SNAP customers with fresh, nutritious fruits and vegetables while supporting local farmers. DTA and Hilltown Mobile Market work together to offer SNAP customers an easy way to pay for these fruits and vegetables, which are called CSA farm shares. Participating in a CSA allows SNAP customers to get fresh produce, support local farmers and save money!

### **I. Monthly cost of a SNAP CSA farm share**

I am interested in buying a SNAP CSA share from *Hilltown Mobile Market*. This SNAP purchase is eligible for the Healthy Incentives Program (HIP) benefit.

**Please check one of the following ways to pay for the SNAP CSA Share:**

\_\_\_\_\_ I agree to pay **\$40.00 per month** in SNAP benefits from my **July** through **November** 2022 benefit issuance (approximately 16 pounds of produce). Total value is \$200.00.

\_\_\_\_\_ I agree to pay **\$60.00 per month** in SNAP benefits from my **July** through **November** 2022 benefit issuance (approximately 24 pounds of produce). Total value is \$300.00.

\_\_\_\_\_ I agree to pay **\$100.00 per month** in SNAP benefits from my **July** through **November** 2022 benefit issuance (approximately 40 pounds of produce). Total value is \$500.00.

If I cannot pay the full balance of my CSA share, Hilltown Mobile Market will change the amount of produce in my share, equal to the amount of what was deducted from my SNAP benefit.

**II. I understand that:** The amount I agreed to above will be automatically deducted from my EBT account on the date that I receive my SNAP benefits. I will pick-up my farm produce (check one):

- The types of produce in my share will change weekly. There is no guarantee on the exact amount of produce. Shares will vary in weight, size and type of produce.
- I cannot return my CSA share for a refund or exchange it for other produce.
- I can cancel my participation in the pilot at any time. If I no longer want to participate, I will contact Seva Water (413)-824-1840 or DTA at DTA.CSA@MassMail.State.MA.US for a cancellation form.
- I will complete and return the cancellation form to *Hilltown Mobile Market* at least 10 days before I receive my next monthly SNAP benefit.
- If I do not return the completed form at least 10 days before that date, my CSA share payment may automatically be deducted from my next SNAP benefit. In that case, the cancellation will take effect the following month.
- I understand that *Hilltown Mobile Market* and DTA will act on my request to cancel my payment as soon as possible.
- I understand that I will not receive a refund for CSA share payments that have already been deducted.
- I agree to participate in a brief survey about this SNAP CSA Pilot at the beginning and end of the CSA season.
- My copy of this agreement, and the notices I will receive each time a payment is deducted from my SNAP EBT account, will serve as receipt of payment.
